

ATTESTATION REOPENING FUND - OPEN ACCESS STREAM (The "Stream")

DECLARE, that

- 1. I am an officer of the Corporation and am duly authorized to declare the following for the Applicant.
- 2. I confirm that I have performed a complete due diligence of all relevant facts for the drafting of this declaration and that I have personal knowledge of said facts.
- 3. I acknowledge that Telefilm Canada ("**Telefilm**") is relying on this declaration to determine whether the Corporation is eligible to access the Stream.
- 4. I have read sections 1 to 3 and 26 to 28 of the *Investment Canada Act* and confirm that the Applicant is a "Canadian controlled" entity, within the meaning given to this expression in the aforementioned provisions.
- 5. No determination or declaration has been made with respect to the Applicant under subsections 26(2.1) or (2.2) of the *Investment Canada Act* and I am not aware of any fact or circumstance as a result of which such a determination or declaration could be made.
- 6. There is no fact or event that could affect the Canadian control of the Applicant.
- 7. The Applicant has its head office, and carries out its activities, in Canada.
- 8. The Applicant did not apply to multiple funding sources to cover the same specific expenditures specifically funds being delivered to by regional development agencies (Major Festivals, Tourism Relief Fund and Community Revitalization Fund) as well as the Canada Emergency Response Benefit, Canada Emergency Wage Subsidy, Canada Emergency Business Account and Canada Emergency Commercial Rent Assistance for small businesses.
- 9. The Applicant is active in the film, television or digital media sector and intends to remain active.
- 10. The Applicant is in need of funding for business continuity and to safeguard jobs.
- 11. Funding under this Stream will be used to cover direct expenses relating to the programming, promotion, delivery and administration of the festival.
- 12. The costs covered by the Stream are not, and will not be, borne by any other entity or program.
- 13. The festival will be held in person or in a hybrid format.

- 14. The Applicant will follow the tips and guidelines included in Public Health Canada's Risk Mitigation Tool for Gathering and Events Operating During the COVID-19 Pandemic for event planners for the organization of the festival.
- 15. If the festival has had a baseline aggregate participation number of 250,000 and above in its 2019 edition, the Applicant confirms that all necessary approvals from all relevant public health authorities have been obtained before the start of the festival.
- 16. The Applicant undertakes to organize and carry out the festival in strict compliance with all applicable municipal, provincial or federal public health measures with respect to the COVID-19 pandemic. The Applicant further undertakes to put in place any other process or procedure that is recommended by applicable industry associations or guilds in order to protect the health and safety of its employees, consultants and collaborators.
- 17. I acknowledge that making a false declaration is considered as an event of default for the Corporation and all its related parties under Telefilm's policies and may constitute a criminal offense.
