

**ATTESTATION OF ELIGIBILITY
THEATRICAL DISTRIBUTION COMPENSATION PROGRAM
(THE “PROGRAM”)**

DECLARE, that

1. I am an officer of the Corporation and am duly authorized to declare the following for the Corporation and its Related Parties, as this term is defined in the Program guidelines (the “**Related Parties**”).
2. I confirm that I have performed a complete due diligence of all relevant facts for the drafting of this declaration and that I have personal knowledge of said facts, and that all information contained in this statement is true and accurate.
3. I understand that only one application may be submitted per Corporate Group, as that term is defined in the Program Guidelines (the “**Corporate Group**”).
4. I understand that a Corporate Group may only access compensation funds from the [Canada Arts and Culture Recovery Program](#) (“CACRP”) once, either through this Program or through the [Theatrical Exhibition Program](#).
5. I acknowledge that Telefilm Canada (“**Telefilm**”) is relying on this declaration to determine whether the corporations covered by the funding application (the “**Beneficiary Corporations**”) qualify under the Program.
6. I have read sections 1 to 3 and 26 to 28 of the *Investment Canada Act* and confirm that the Beneficiary Corporations are “Canadian controlled” entities, within the meaning given to this expression in the aforementioned provisions.
7. No determination or declaration has been made with respect to the Beneficiary Corporations under subsections 26(2.1) or (2.2) of the *Investment Canada Act* and I am not aware of any fact or circumstance as a result of which such a determination or declaration could be made.
8. There is no fact or event that could affect the Canadian control of the Beneficiary Corporations.
9. The Beneficiary Corporations operate as feature film theatrical distribution companies, have their head offices in Canada and carry on business in Canada.
10. The Beneficiary Corporations do not distribute in theatres exclusively feature films produced by them or by their Related Parties.
11. Each of the Beneficiary Corporations has distributed in theatres at least two (2) Canadian feature films* between January 1, 2018 and September 1, 2022.

* For the purposes of this Program, a **Canadian feature film** is a fictional or documentary film of **75 minutes or more** that has received **either a minimum of 6 out of 10 points** from the Canadian Audio-Visual Certification Office (CAVCO) **or a preliminary or final recommendation by Telefilm as an audiovisual coproduction governed by a Canadian treaty.**

12. The Beneficiary Corporations did not apply to multiple funding sources to cover the same specific expenditures – specifically the Canada Emergency Response Benefit, Canada Emergency Wage Subsidy, Canada Emergency Business Account and Canada Emergency Commercial Rent Assistance for small businesses.
13. Funds allocated under this Program will be used only for the purposes stated in the Program guidelines.
14. The costs covered by the Program are not, and will not be, borne by any other entity or program.
15. The Beneficiary Corporations intend to remain active in the theatrical distribution of feature films in Canada for a minimum period of eighteen (18) months following the submission of the funding application to Telefilm.
16. In-person events, if any, will be held in strict compliance with any applicable municipal, provincial, or federal health measures related to the COVID-19 pandemic.
17. I acknowledge that making a false declaration is considered as an event of default for the Corporation and all its Related Parties under Telefilm’s policies and may constitute a criminal offense.
