Once determined, the performance ratio sharing cannot be changed, nor assigned to another company even of the same corporate group. Telefilm reserves the right to withdraw the privileges associated with the performance ratio of an entity if the principals of that entity change.

Furthermore, the Applicants understand that the performance ratio sharing may be used to help assess creative, financial and distribution control, including for projects submitted under the Indigenous stream of the Production program or to determine which region the project should be coded to.
