(This definition is inclusive of international Indigenous Nations and those who identify as both Black and Persons of Colour).

- 5. How do you describe your gender identity? Fondation Émergence and GLAAD describe gender identity as a person's internal, deeply held sense of their gender. Gender identity refers to how a person defines their gender based on a deep, personal knowledge of belonging (or lack of belonging) to one or several genders: man, woman, somewhere in between, both or neither. This intimate experience is unique to each person. It is not determined by a person's biological sex and can be at odds with the sex assigned at birth. Unlike gender expression (see below) gender identity is not visible to others.

## Appendix A Personal Information Collection Statement – Advisory Committee Members

At Telefilm Canada ("**Telefilm**"), greater diversity, inclusion and equity are at the heart of our values. Telefilm aims to create advisory committees which are reflective of regional and cultural diversity as well as underrepresented groups and gender parity. These advisory committees assist Telefilm in reviewing different projects submitted under its financing programs and make recommendations.

This Statement explains why personal information is being collected and what it will be used for.

The personal information of individuals interested in being considered for advisory committees is collected for the purposes of identifying and selecting individuals to serve on advisory committees. This personal information may also be used to maintain an inventory of potential candidates. Such personal information may include, among other things, first and last names, contact information (e.g. email address, phone number, mailing address), biographical information, work history or curriculum vitae (resume), region, as well as specific program or advisory committee.

Furthermore, additional personal information provided by candidates on a voluntary basis through self declaration is collected for the purposes of fostering the creation of advisory committees which reflect regional and cultural diversity as well as underrepresented groups and gender parity. Such personal information may include, among other categories, whether a candidate is Indigenous or self-identifies as 2SLGBTQ2IA+, Black, a person of colour, a woman, a person with disabilities, or belonging to an official language minority community.

In the case of selected candidates, other personal information may be collected for the purposes of administering their participation as advisory committee members. Such personal information may include, among other things, financial institution information, social insurance number (SIN) and conflict of interest declarations.

The collection and use of personal information are in accordance with the *Telefilm Canada Act*, the *Canadian Human Rights Act*, the *Canadian Multiculturalism Act* as well as (where applicable) the *Income Tax Act* and are in line with the provisions of the *Privacy Act*. In addition, such information may be used for statistical, planning, evaluation and reporting purposes, as well as communications materials (e.g.; press releases including advisory committee membership). The information is included in the personal information banks <u>Members of Boards</u>, <u>Committees and Councils (PSU 919)</u> and Voluntary Self-Identification (TFC PPU 025).

The personal information collected and used, among other things, for the purposes of assessing advisory committee membership will be available to individuals occupying work positions that have a valid reason for accessing and using this personal information (the "designated staff"), including, but not limited to, designated staff in the department administering the program under which the advisory committee is to be set up. In the case of selected candidates, personal information may also be shared with designated staff in Telefilm's Finance, Legal Services and Communications departments, among others.
