NOTE: If you plan also to apply to Telefilm for CFFF and/or Mini-Treaty financing for feature film, please submit a <u>financing application</u>. Telefilm's CFFF and Mini-Treaty financing application now includes the coproduction certification application too.

If you have already applied to Telefilm for CFFF and/or Mini-Treaty financing for feature film (and indicated the project is a coproduction), you need <u>not</u> apply separately for the preliminary recommendation; Telefilm will open the coproduction file for you.
